Amplio (formerly Literacy Bridge) is a U.S.-based nonprofit organization committed to sharing knowledge with the world's hardest-to-reach communities, so that people in developing countries have the power to transform their lives. Our program accomplishments in 2018 include:

CARE Pathways Program

Funded by the Bill and Melinda Gates Foundation, the CARE Pathways program in Ghana came to a close in November 2018. Amplio's CARE Pathways partnership began in 2015 as one-year project using Talking Books to provide access to information and empower low-literate women farmers in 65 Village Saving and Loan Associations (VSLAs) to improve food security and nutrition for their families in Ghana's Upper East Region. In 2016, the project was extended and it expanded to reach 145 VSLA groups in Garu and 55 VSLAs in Lambussie, in the Upper West Region, for a total of 200 groups – approximately 2,000 direct beneficiaries. Talking Book content was updated quarterly with messaging about soybean and ground nut cultivation, market links, nutrition, and gender issues.

In the close-out survey, respondents said Talking Books helped reinforce the Pathways training and lessons and also offered new knowledge, with a focus on gender. Some of the most cited messages were about growing soybeans and ground nuts to earn income and improve soil fertility, nutrition during pregnancy, and shared decision making and household chores.

Amplio's partnership with UNICEF Ghana began with a pilot project in 2013 and has gone through several contract renewals and program expansions. In 2018, UNICEF's Communication for Development program used Talking Books in three districts in the Upper West and Northern regions, reaching 56 communities in Jirapa, 21 in Tolon, and 18 in Karaga. Talking Book content was updated quarterly, addressing four sectors: Health, Education, Child Protection, and WASH.

UNICEF's Talking Book program model combines household listening with community dialogues. On average, participating households listened to Talking Books three hours per week and played messages two-to-four times. The community dialogues helped reinforce Talking Book knowledge, providing a safe space for men, women, and youth members to discuss challenges and barriers to practicing, adopting, and maintaining healthy behaviors and develop locally-appropriate solutions to overcome limiting factors to behavior change.

Additionally, in 2018, Amplio, UNICEF Ghana, Literacy Bridge Ghana, and Ghana Health Services worked together on a new initiative that will use Talking Books to support community health nurses through Ghana's Community-based Health Planning and Services program.

MEDA's Greater Rural Opportunities for Women (GROW) project

Funded by Global Affairs Canada, MEDA's Greater Rural Opportunities for Women (GROW) project empowered over 23,000 women farmers to the Upper West region of Ghana to improve their household food security and incomes by growing, selling and using soy.

Talking Book devices were distributed to 1,016 Lead Farmers, each of whom provided agronomic information for a group of women farmers in their village. The Lead Farmer was often the only source of information about how to plant, grow and harvest crops for these women. The use of Talking Books strengthened GROW's technical outreach and allowed the women to access the information at a convenient time, as well as share information with their families. MEDA also successfully used Talking Books to rapidly deploy messages to educate farmers about how to deal with a fall armyworm infestation, helping to prevent crop destruction.

When the GROW program came to a close in December 2018, the close-out survey showed Talking Books were a key source of information across GROW communities for topics covered, including agriculture practices, health and nutrition, financial literacy, market chains, and gender roles. GROW farmers said the Talking Book gave them access to knowledge to grow more food and earn income, resulting in greater confidence and social status.

Afya Timiza Project

In Kenya, Amplio's affiliate, Centre for Behaviour Change and Communication (CBCC) is using Talking Books to train and support hundreds of community health volunteers (CHVs) for Afya Timiza, a six-year, USAID-funded initiative to improve health outcomes in nomadic, pastoral communities. In 2018, CBCC launched a program to improve maternal, newborn, and child health in Samburu and Turkana counties. In intervention sites, where CHVs use Talking Books to share consistent, quality health messages, community trust and participation in health services significantly increased. Intervention health facilities have seen a 100% increase in the number

of pregnant women completing four ANC (prenatal) visits – and a 41% increase in new ANC clients (compared to a decrease in clients in other communities).

In 2018, CBCC used Talking Books to train 821 CHVs on maternal and newborn health and built capacity for 614 CHVs on family planning literacy. As a result, 8,741 women accessed skilled delivery services and more than 27,859 individuals received family planning services.
